The village reserves the right to limit the number of permits issued.

Permits are available on a first come, first serve basis. They may be obtained at the Village Hall, 478 Piermont Avenue, Piermont, NY 10968, Monday through Friday from 9 am to 3:30 pm and by mail.

**Fees are non-refundable, and will not be pro-rated. Permits are valid for the vehicle bearing the above license number only and are not transferable. Daily Permits are available at a cost of \$10.00 per day. Replacements available only upon return of original hanging pier permit.**

By signing this form, the applicant affirms that he has received a copy of the rules and regulations pertaining to the use of the pier, that he has read and understands them, and agrees to abide by them. Hanging permits are to be placed on the rearview mirror.

***WARNING: False statements made herein are punishable as a Class A Misdemeanor pursuant to Section 210.45 of the New York State Penal Law.***

**PIERMONT PIER RULES AND REGULATIONS**

1. Use of the pier shall be deemed a privilege. All users shall identify themselves upon the request of authorized officials. Permission to enter the property may be revoked at any time for any reason and fees will not be refunded.
2. **Place the hanging pier permit on the rearview mirror.**
3. Maximum speed limit for all vehicles shall be fifteen (15) miles per hour. **Parking is permitted in designated areas only.**
4. No person shall damage or destroy any plants, animals, birds or other natural or man-made features of the property.
5. All refuse shall be disposed of in receptacles provided for that purpose. Littering is strictly prohibited.
6. Fires are prohibited except in self-supporting barbecue grills or stoves and will be under the direct supervision of a person over 18 years of age at all times.
7. The launching of boats, of any description, from the pier is strictly prohibited.
8. The launching of any water-skis, aquaplanes, jet skis, parasails or any other water related device from the pier is strictly prohibited.
9. Firearms, slingshots, pellet guns, air rifles, fireworks, explosives, knives and any other weapon are prohibited.
10. Swimming and wading are prohibited.
11. All applicable laws of the Village of Piermont, County of Rockland, State of New York and the Federal Government shall be complied with.

The pier gate will be open from sun-up to sun-down. Vehicles left on the property after closing time may be towed away at the owner's expense.

***A VIOLATION OF ANY OF THE FOREGOING RULES AND REGULATIONS MAY RESULT IN A  
REVOCATION OF THE PERMIT AND THE PRIVILEGES GRANTED THEREIN.***

***IN ADDITION, VIOLATIONS OF THESE RULES AND REGULATIONS MAY ALSO CONSTITUTE A  
VIOLATION OF THE VILLAGE LAWS AND CONVICTION MAY SUBJECT A PERSON TO A FINE NOT  
EXCEEDING \$500.00 OR IMPRISONMENT NOT EXCEEDING 15 DAYS OR BOTH.***
